UN University Volunteers have to be 29 years old throughout the entire period of service, i.e. born on or after 1 September 1992.

Living Conditions

The volunteer will reside in Santo Domingo, capital of the Dominican Republic, which has basic services of electricity, water, telecommunications.

The city has a network of supermarkets and stores for food and other consumer goods. The public transport network is poor, so private transport such as taxis must be used. There is a large supply of homes and apartments for rent, which can be obtained through real estate services.

The Dominican Republic has a tropical climate throughout the year. The average annual temperatures range between 20-32°C, and the

Organizational Context & Project Description

The United Nations Children's Fund (UNICEF) is the United Nations agency that has the mandate to guarantee the fulfilment of the rights of children and adolescents throughout the world. UNICEF has been working in more than 190 countries and territories to protect the rights of all children, in terms of survival, development, protection and social participation, since 1946.

UNICEF has collaborated with the Dominican Government since 1952, the year in which the first Basic Cooperation Agreement was signed. The current Cooperation Program with the Dominican government 2018-2022, has a transversal gender axis in order to guarantee better results for children and adolescents, promoting the change of social norms and harmful practices such as violence against children, child marriage and early unions, sexual exploitation and abuse, among others.

The support to be carried out by the UNV may support the four Programmatic Component (Education, Health, Child Protection and Social Inclusion), as transversal support, but it will focus on the Social Inclusion program, which coordinates the initiatives and projects aimed at preventing child marriage and early unions.

Task description

Under the direct supervision of the C4D officer (Gender Focal Point), the UN Volunteer will undertake the following tasks:

1. Support the functions of the Gender Focal Point in order to:
 - Ensure the mainstreaming of the gender approach and the implementation of activities in all programmatic components.
 - Contribute to the Gender Program Review (GPR) and the design of the CPD.
 - Support internal training and gender focus partners.
 - Contribute to the review of drafts reports (to donors and internal), ensuring the incorporation of the gender perspective.
 - Assess and identify gender needs for emergency preparedness and/or in case of emergency.
2. Support the development of initiatives for the prevention of Child Marriage and Early Unions.
3. Participate in the Programme and all staff meetings.
4. Participate in inter-agency meetings, especially the Inter-agency Gender Group, under direct supervision of the gender focal point.
5. Participate in teleconferences organized by UNICEF (HQ and LACRO).

Furthermore, UN Volunteers are required to:- Strengthen their knowledge and understanding of the concept of volunteerism by reading relevant UNV and external publications and take active part in UNV activities (for instance in events that mark International Volunteer Day)- Be acquainted with and build on traditional and/or local forms of volunteerism in the host country- Provide annual and end of assignment reports on UN Volunteer actions, results and opportunities using UNV's Volunteer Reporting Application- Contribute articles/write-ups on field experiences and submit them for UNV publications/websites, newsletters, press releases, etc.- Assist with the UNV Buddy Programme for newly-arrived UN Volunteers- Promote or advise local groups in the use of online volunteering, or encourage relevant local individuals and organizations to use the UNV Online Volunteering service whenever technically possible.

- The development of capacity through coaching, mentoring and formal on-the-job training, when working with (including supervising) national staff or (non-) governmental counter-parts, including Implementing Partners (IPs);

This is at the discretion of the host entity. Candidates proceeding to interview are recommended to discuss the likelihood of travel and possible alternative arrangements with the host entity. If selected, candidates should carefully consider the circumstances before accepting UNV's offer.

In cases where the UN Host Entity partner has requested the UN Volunteer to perform their assignment remotely, the Post Adjustment Multiplier (PAM) and related entitlements to be paid may be adjusted to the temporary duty station from where the UN Volunteer has been requested to work if requested by the UN Host Entity.

The United Nations Volunteers (UNV) programme is administered by the United Nations Development Programme (UNDP).

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) per month and is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of (choose from the drop down menu the appropriate rate here): US\$1,009 The VLA base rate is a global rate, while the PAM is country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website <http://icsc.un.org>.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis. .

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the UN Volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and also in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements). UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for the final repatriation travel (if applicable). UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.

Supervision, induction and duty of care of UN Volunteers ([Roles and Responsibilities of Host Entities](#))

UN Volunteers should be provided equal duty of care as extended to all host entity personnel. Host entity support to the UN Volunteer includes, but is not limited to:

- Introductory briefings about the organisation and office-related context including security, emergency procedures, good cultural practice and orientation to the local environment;
- Support with arrival administration including setting-up of bank accounts, residence permit applications and completion of other official processes as required by the host government or host entity;
- Structured guidance, mentoring and coaching by a supervisor including a clear workplan and performance appraisal;
- Access to office space, equipment, IT support and any other systems and tools required to complete the objectives of the assignment including a host entity email address;
- Access to shared host entity corporate knowledge, training and learning;
- Inclusion of the volunteer in emergency procedures such as evacuations;
- Leave management;
- DSA for official travel, when applicable;
- All changes in the Description of Assignment occurring between recruitment and arrival or during the assignment need to be formalized with the United Nations Volunteer Programme;
- Investigate misconduct: sharing reports with the UNV;

- Provide emergency assistance, e.g. the death of volunteer or medical evacuation, in collaboration with UNV. Accept letters of guarantees or potential liabilities for covering medical costs not claimable under medical insurance in extraordinary situations (e.g. isolation facilities` services during pandemics)
